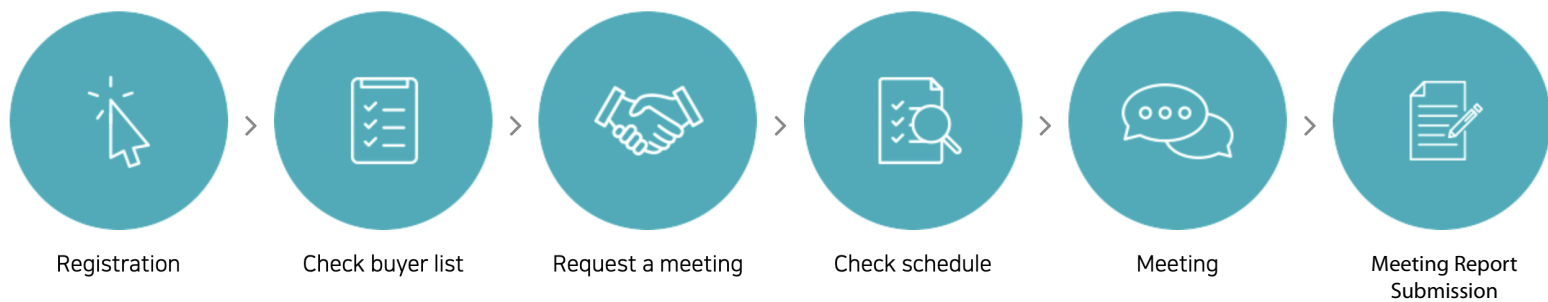

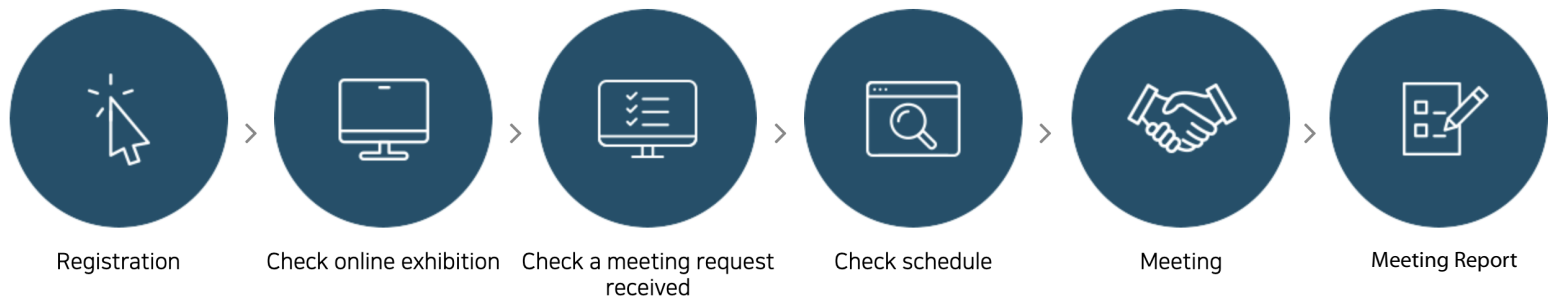

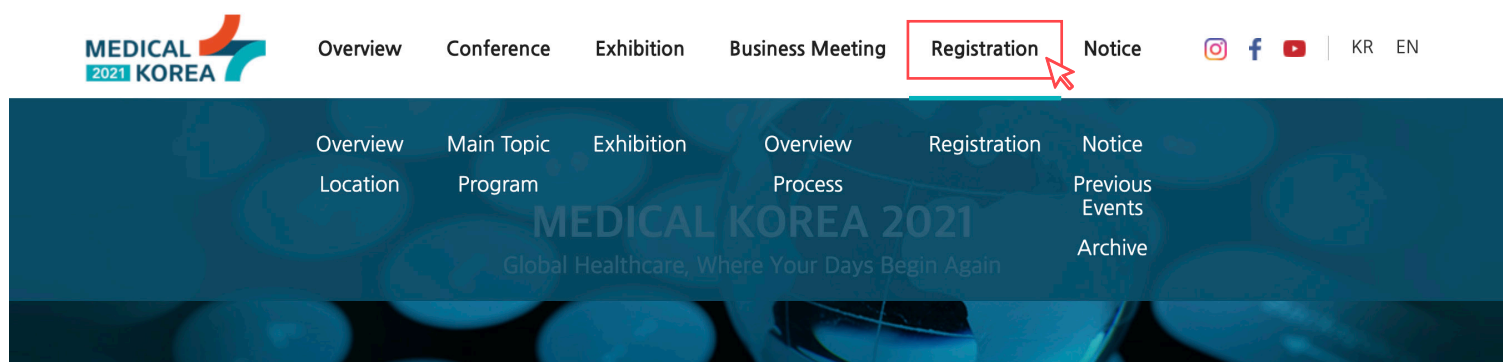


How to register for the Business Meeting

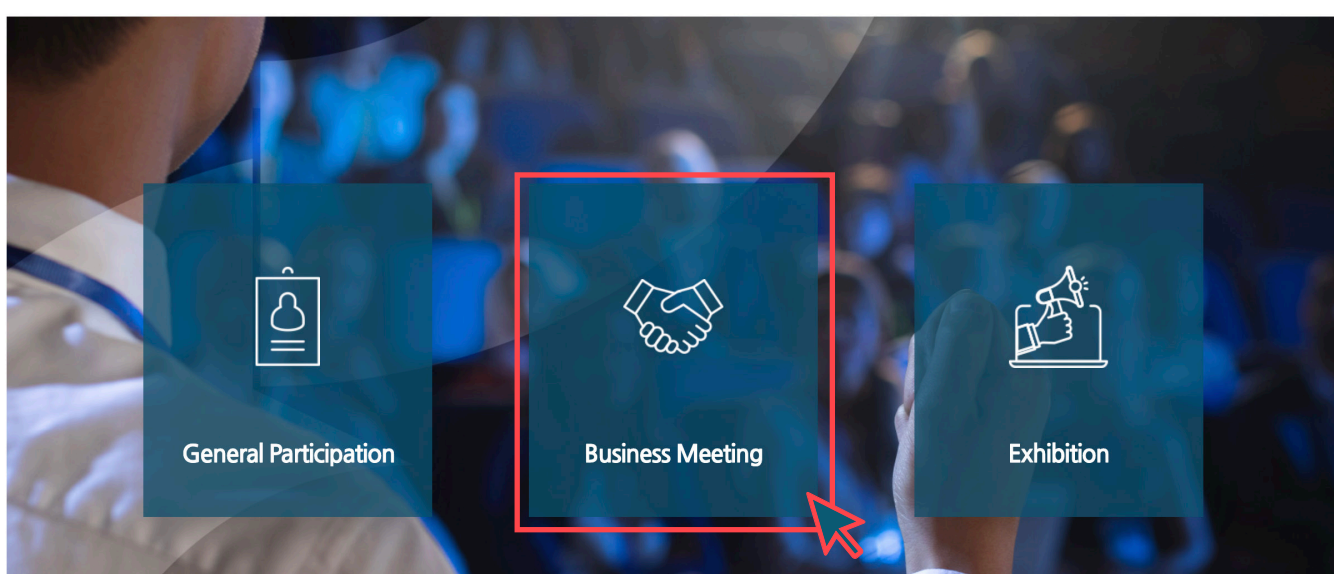
All participants must complete an online registration. Please read the instructions carefully.
